PROCESS OF THE AUDIT:

UPON THE CLIENT'S REQUEST ITEM A.) AN INDEPENDENT AUDIT OF WALLETS IN CUSTODY OF FUMBI NETWORK J. S. A. (FURTHER ON REFERRED TO AS A "CLIENT") WAS PERFORMED.

IN COURSE OF THE AUDIT, THE BALANCE OF CRYPTOCURRENCIES IN INDIVIDUAL WALLETS WAS COMPARED WITH THEIR CURRENT VALUES LISTED ON INDIVIDUAL BLOCKCHAINS.

THE BALANCE OF THE AUDITED CRYPTOCURRENCIES IN INDIVIDUAL WALLETS WAS SUBMITTED BY THE CLIENT AS AN EXPORT FROM THE PRODUCTION DATABASE CREATED ON JULY 14TH, 2020 AT 9:31 AM, CONTAINING UPDATED BALANCES OF CRYPTOCURRENCIES IN INDIVIDUAL WALLETS.

THE EXPORT ITSELF CONTAINED WALLET BALANCES OF 26 CRYPTOCURRENCIES, TOGETHER WITH THEIR CURRENT RESPECTIVE EXCHANGE RATES, THE SUMS OF INDIVIDUAL CRYPTOCURRENCIES CONVERTED TO EUR AND THE PUBLIC KEYS TO INDIVIDUAL WALLETS, SERVING AS A REFERENCE IN SEARCHING FOR CURRENT VALUES OF CRYPTOCURRENCIES LISTED ON INDIVIDUAL BLOCKCHAINS. BLOCKCHAIN EXPLORERS LISTED IN THE FOLLOWING TABLE WERE USED AS A SOURCE OF COMPARISON.
